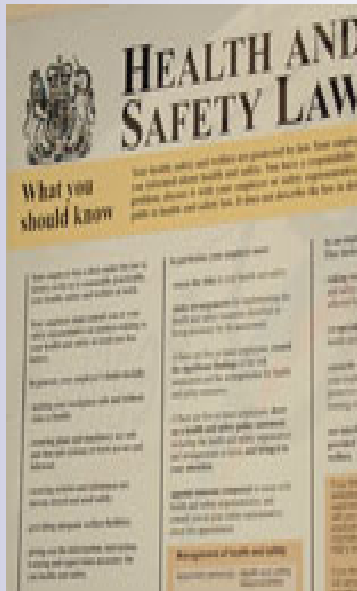

Problem Solving & Decision Making

Much of what managers and supervisors do is solve problems and make decisions. New managers and supervisors, in particular, often make solve problems and decisions by reacting to them. Communication Skills

Good communication skills are skills that facilitate people to communicate effectively with one another. Effectual communication engages the choice of the best communications channel, the technical know-how to use the channel, the presentation of information to the target audience, and the skill to understand responses received from others. Self development, interpersonal skills, mutual understanding, mutual cooperation and trust is also important to set a complete channel of most effective and winning communication skills.

The course has been designed for use with all levels of staff and is intended to help participants identify what makes effective communication and the specific skills they will need in order to be effective communicators.

Level 2 Award in Fire Risk Assessment

Employers have responsibility for ensuring the health, safety and welfare of their employees and others who may have access to the workplace. These general duties include safety in relation to fire hazards, both from the work processes and activities, as well as general fire safety in the workplace.

The risk assessment is to enable employers to identify, and then take steps to eliminate, reduce or control safety risks (including risks from fire), to make sure that nobody gets hurt or becomes ill.
